



The TCTA Scholarship Program was established by the late Charles and Phyllis Gottlieb to provide financial aid to students who are not at the top of their class, do not have other scholarship opportunities, and who face current hardships or challenges that might make higher education or career/vocational training difficult or even impossible to attain without assistance. Rather than focusing on academic records, TCTA will select award recipients based primarily on the qualities they have demonstrated that make them likely to succeed if given the chance.

Eligibility: Students must be nominated by a high school teacher or counselor. To be nominated, a student must:

- be a high school senior
- be a U.S. citizen and reside in Texas
- demonstrate financial need (at or below twice the federal poverty level)
- have a minimum GPA of 2.0 on a 4.0 scale, and
- demonstrate traits of strong personal character and potential for success, as determined by the nominating educator.

Preference will be given to students who are first in their families to seek higher education, and to those whose family incomes do not exceed twice the poverty level (as defined by the U.S. Health and Human Services Department). TCTA membership of a nominator or the parent of a nominee is neither an advantage nor a disqualifier. However, teachers and counselors may not nominate their own children.

Awards: Scholarships may be awarded in amounts of up to \$5,000 per year for tuition and required fees to assist students pursuing courses of study leading to recognized degrees at accredited two- or four-year colleges, community colleges or career/technical schools. The amount awarded will be determined on a case-by-case basis. Any discounts or tuition waivers and other financial assistance the student receives will be considered when determining the amount of the scholarship. Scholarships may be renewed annually for up to four years based on satisfaction of criteria and available funding, though renewal is not guaranteed. To be eligible for renewal consideration, recipients must maintain good academic and disciplinary standings, earn a minimum 2.5 GPA on a 4.0 scale, and complete at least 12 academic units per semester or equivalent for a grade.

Applications: Student applications are incomplete and will not be considered by the scholarship committee until the following materials are received:

1. completed student application
2. official, sealed transcript from registrar's office
3. high school teacher/counselor nomination form (Nominator may submit directly to TCTA online or via mail, or student may mail with above materials.)
